Dear Parent / Guardian,

I am delighted to inform you that the planned camps for Years 7 and 8 to Normanby Park will be going ahead.

Despite the recent outbreak of COVID in our school and wider community, we have thoroughly risk assessed the venture and following the 'circuit break' of transmission that is currently in place, feel that it would be detrimental to the mental health and well-being of our students to cancel the planned residential. (Particularly with only a week to go).

As a parent / guardian, you have committed to your child attending and I do hope that you will continue to recognise the benefits of the experience and to support the school with your child's attendance.

Option 1:

I would like my child to attend camp as per the original plans. I will drop them off at the allotted time at the start of camp and collect them at the agreed time at the end of camp.

I will ensure that a COVID test is taken the evening prior to attending camp and I give my consent for my child to be COVID tested on their arrival at camp.

Option 2:

I would like my child to attend a day camp. I will drop them off between 8.00 -8.30am on a daily basis and collect them at 6.30pm each evening (with the exception of the final day of camp when I will collect them at the agreed time of 2.45 - 3.00pm)

I will ensure that my child takes a COVID test the evening before attending camp and I give consent for my child to be COVID tested each day when they arrive at camp.

Option 3:

I would like my child to attend school as normal.


